Delegated and Implementing Acts on the CAP Reform

At the end of December 2013 the <u>Basic Regulations for the reformed Common Agriculture Policy</u> were published in the Official Journal. This includes the regulations on Direct Payments, the Common Market Organisation, Rural Development and a Horizontal Regulation on the financing, management and monitoring of the CAP. As far as the implementation of the reform is concerned, the Commission has published delegated and implementing acts linked to support for rural development by the EAFRD (supplementing the "Rural Development" Basic Regulation (EU) No 1305/2013). Member States now have all the detailed elements they require in order to programme and implement rural development support. European Masters Program for Rural Animators

European Masters for Rural Animators is a on-line master in English that consists of four semesters. Contents have been developed by leading researchers on each field. One report looks at how to digitise, make accessible and preserve culture online, the second report explains how our film heritage can be rescued from rotting cans. Digitised cultural material is a great common and free resource for developing cultural and educational content, documentaries, tourism applications, games, animations and design tools.
