#### Launch of a Report on "Empowering Rural Stakeholders in The Western Balkans", 6 October 2014, Brussels

Regional Rural Development Standing Working Group in South Eastern Europe and PREPARE are organizing the launch of the <u>report "Empowering rural stakeholders in the Western Balkans"</u> at the European Parliament with the presence of Commissioner Dacian Cioloş and Commissioner-elect Phil Hogan (tbc). This report reflects the conclusions of a stimulating series of <u>traveling workshops and conferences held in April 2014 in the Western Balkans, with a Concluding Conference held in Brussels on 8 April.</u> Taking part in these events were Ministers with responsibility for agriculture and rural development, and representatives of public authorities and civil society organizations, from all the countries of the Western Balkans. ### PREPARE Gathering 2014, Finland and Estonia, 5-9 September 2014

30 participants from 23 countries participated at the series of events within the PREPARE Gathering 2014, held in Finland and in Estonia. Travelling workshops around Helsinki and Tallin were good inspiration for participants and several good practices, visited during the travel seem to be relevant for implementation in other parts of the Europe. Central event of the Gathering was the conference, devoted to the process of preparation for the next European Rural Parliament. Creative participants contributed significantly to that process and most of them expressed their enthusiasm about the raising the rural voice through national and European rural parliaments. More...

#### PREPARE Appointed for a Period of 7 Years as a Member of the Civil Dialogue Group for Rural Development

On 18 July 2014 the Director-General of the Commission's Directorate-General for Agriculture and Rural Development decided on the composition of the civil dialogue groups, each covering a different subject relating to the common agricultural policy, including rural development, and its implementation. Civil dialogue groups provide an important forum for consultation, providing high-level input from a wide range of sources and stakeholders in the form of opinions, recommendations and reports, complementing other sources, consultations and inhouse expertise of the Commission. ### **European Rural Sustainability Gathering, Beaufortain, France**

forum synergies This year between 18 to 21 September Forum Synergies' European Rural Sustainability Gathering took place in Beaufortain territory in France with around 50 participants from 16 countries, half of them below 35, enthusiastically interested in good farming, rural renaissance and sustainable food chains. Many participants came from the South East Europe, Serbia, Macedonia, but also Ukraine through the PREPARE or Slow Food movement's context, Estonia, Sweden (Hela Sverige Ska Leven), Poland, Euroacademy etc. Meeting was hosted by Savoie Vivante, a very dynamic and impressive organisation and network focussing on youth, territorial dialogue, training and animation in the region. Participants discussed about better cooperation across network partners. Soon it will be available also a report on the outcome and action points of the meeting.

#### **EEB Reaction to Juncker Commission: Bad Blow to Environmental Sustainability**

The EEB (European Environmental Bureau) has reacted with deep concern to the structure of the proposed new Commission that was unveiled by Jean-Claude Juncker: "Instead of putting sustainability central to his new team, Juncker has decided to relegate it to the margins by scrapping the dedicated posts of a climate and an environment commissioner and appointing a deregulation first Vice-President to put a competitiveness filter on all initiatives", EEB Secretary General Jeremy Wates commented on the announcement. It is crucial that in merging the climate and energy portfolios, and environment and maritime affairs and fisheries, no resources for acting on climate change or environmental sustainability are lost. #### **New Agriculture Commissioner Told to Simplify Greening, Payments**

Simplification of the direct payments in the Policy and greening are two of the issues that have been put top of the list of priorities for the new Commissioner for agriculture designate, Phil Hogan. In the brief that has been given to the new agriculture commissioner, the European Commission President Jean-Claude Juncker has told him to concentrate his efforts on implementing eh new CAP reforms. But he has also been told to simplify the system of direct payments within a year in particular in the areas of greening, rural development, quality policy and the fruit and vegetables scheme. #### **European Commission and EIB sign Memorandum of** Understanding for co-operation in agriculture and rural development

Commissioner for Agriculture and Rural Development Dacian Cioloş and Vice President of the European Investment Bank (EIB) Wilhelm Molterer signed on 15 July 2014 a Memorandum of Understanding (MoU) between the European Commission and the EIB for co-operation in agriculture and rural development in 2014-2020. The first of its kind in the field of agriculture, this MoU paves the way for common initiatives by both institutions, so as to stimulate rural development and boost the utilisation of financial instruments supported by rural development funds. #### **Outputs and Documents of Central Europe Annual Conference 2014**

The annual conference in Vienna (1-2 July 2014) linked the old to the new Central Europe Programme. Achievements of 124 projects implemented in the past seven years were presented and discussed among project partners, policy makers and other stakeholders from all over central Europe. More...

#### **COSME – Sustainable transnational tourism products**

The main objective of this call is to strengthen competitiveness of the European tourism sector as well as its sustainability by encouraging diversification of the supply of tourist services and products. The project proposals should aim at promoting sustainable transnational tourism products (such as e.g. routes, itineraries, trails, tourism offer...) in sport or wellness activities in relation to one of the following types of tourism: coastal or maritime or mountain or rural tourism. #### <u>Consultation on The urban dimension of EU policies – key</u> features of an EU Urban Agenda

Europe continues to be faced with challenges related to the economy, the climate, the environment, and society at large. Most of these challenges have a strong urban dimension. But although cities' role for economic, social and cultural development, and their potential for a more resource efficient habitat, have long been recognised, the policy response at European and national level has been slow and piecemeal, with many but poorly integrated sectoral initiatives. #### <u>Consultation on the EU Strategy for the Alpine Region</u> (EUSALP)

The EU Macro-regional Strategy for the Alpine Region aims to bring a new impetus for cooperation and investment to the benefit of all involved: States, regions, civil society stakeholders and, above all, European citizens. It will build on a long tradition of co-operation in the Alps, and will seek to complement, rather than duplicate existing co-operation structures. This also aims to ensure that this Region remains one of the most attractive areas in Europe, taking better advantage of its assets and seizing its opportunities for sustainable and innovative development in a European context.
